Obey Allah and obey the Messenger and Ulil Amri among you. Then, if you dispute over anything, return it to Allah and the Messenger, if you believe in Allah and the Last Day. That is better and better in theend."* From this verse, it is one of the liabilities of Muslims especially young men to fight in the way of Allah in the form of martial country in order to realize the vision of *Indonesia Emas 2045*.

Litetature Review

National Power

Power has always been a very important concept in the study of international relations. Power must understand the nature and motivation of national power. How power affects the behavior of individuals, groups and nations, in which

case the state is always moving to become a super *power* state as we have seen, power is the ability to influence the behavior of others to achieve the desired results. Of course, a country needs to understand its national power that affects other countries. According to Hans J. Morgenthau (1990), the power of the country is distinguished into several factors, including geographical factors, natural resources, industrial capabilities, military readiness, population, characteristics of the nation, national spirit, and the quality of diplomacy.

In general, the geography of a region can affect the national strength of a country. The geographical conditions of a country can formulate to make state policies. A country can exploit a region within a country based on its geographical conditions. This supports the geopolitical theory put forward by researchers. And it is also supported by Kenneth Waltz (1975) that each country has different characteristics, as well as geographical conditions. The geographical conditions of a country can produce diverse capabilities. For Indonesia which is geographically a maritime country that has many islands can make its potential as a strong country.

A country will not be taken into account by its geographical potential alone. The population factor can be a force for a country. The geographical conditions of a country will not be useful if it is not developed by its inhabitants. As the researchers explained in the previous paragraph, human productivity is key in developing the country's geographic potential. In the development of industrial capabilities, the population becomes an important aspect in developing industrial capabilities. The amount and innovation contributed by the population becomes a strength for the industry. In the aspect of statehood (Indonesia), the population can develop with the times so that it can make Indonesia a strong country demographically.

A large population will not be great for the development of a country. Population growth must be balanced with a strong character. National character according to Morgenthau became an important key in national strength. The character can at least be a culture that is deep-rooted for society so that it can be implemented for the national interest of a country. Indonesia which is a maritime country if it can become its own culture for its people so that it can make Indonesia as the world's maritime axis.

With the national character attached to the community, it will give birth to the national spirit. The national spirit is the level of determination of a person in supporting the domestic and foreign politics of his country. This spirit is illustrated by the concern of the population in supporting the policies of his country. Not only from the population, the quality of government that is trusted by the people in making the national spirit extraordinary so that it can be taken into account by other countries. (Morgenthau, 1990)

Basically from this concept has a connection with national vigilance. National vigilance is a quality of preparedness owned by the Indonesian nation to detect, anticipate early and take preventive measures against various forms and properties of potential threats to the Republic of Indonesia.(Riyanto, 2017)

Bela Negara and Islamic View

The defense of the state has actually been summarized constitutionally precisely contained in Article 27 paragraph (3) of the Constitution of the Republic of Indonesia 945, namely *"every citizen has the right and obligation to participate in the defense of the state"*. Article 27 paragraph (3) states that: *"Each*citizen has the right and obligation to participate in the defense and *security efforts of the state"*.

Bela negara is a *constitutional* term contained in article 27 paragraph (3) of the Constitution of the Republic of Indonesia Year 945 which reads *"every citizen has the right and obligation to participate in the defense of the state"*. This means that constitutionally defending the state binds the entire Indonesian nation as the rights and obligations of every citizen.

Bela Negara is related to the guarantee of the existence of the Republic of Indonesia and the realization of the nation's ideals as contained in the Opening of the NRI Constitution of 945, namely: Protecting the entire Indonesian nation and all Indonesian blood, Advancing the general welfare, Educating the life of the nation, and participating in implementing world order based on independence, lasting peace and social justice. After the Proclamation of Independence in 945, the Indonesian nation has carried out efforts to Bela Negara persistently to overcome various forms of threats that come from within the country or abroad. Thanks to the growth of a tenacious and resilient national character based on the basic values that exist in the conception of NKRI based on Pancasila and the 945 Constitution, and the conception of nationality based on *Bhinneka Tunggal Ika*, the Indonesian nation

In addition to being regulated in the positive legal norms of the obligation to defend the state is also a religious order. The legitimacy of the naqli proposition about the duty of defense of the state is spread in several verses of the Qur'an, just as Allah says: "O believers when you meet the disbelievers who are attacking you, then do not turn your back on them (retreat). Whoever retreats at that time unless he turns war or wants to join forces with another army, then the man returns with wrath from Allah and his place is hell jahannam. And it is a very bad place of return." (QS. Al-Anfal 5-6). The verse can be understood as the basis of obligation and socio-historical, in order to always defend the dignity and sovereignty of the state.

And it is mentioned in the Qur'an how Abraham as prayed for the land he lived in (Makkah) to be secure and prosperous. *And (remember) when Abraham prayed, "My Lord, make this city a city of peace and security, and provide for its people who believe in Allah and the Last Day."* ...". (QS: Al-Baqarah: 26).

The love of this homeland is also recorded well in the hadith of the Prophet (peace be upon him), as narrated by Ibn Abbas, he said: "*It would be nice for you as a country and you are the country that I love the most. If my people had not driven me out, I would not have lived in a land other than yours.*" (HR. Ibn Hibban).

The basis of the Qur'an and hadith is very clear that the concept of Bela Negara really exists in Islam. Although some groups reject the concept as being associated with political Islam, historical records are practiced. The experiences during the reign led by Islamic figures always leave heroic stories of how Muslims love their country in many expressions.

Islam is a comprehensive religion. All his teachings, instructions, and prohibitions encapsulate all aspects of human life. There is also the concept of Bela Negara. Many people think that the concept of defending the state is contrary to Islam which requires *harmony* between fellow Muslims without any state barrier(Time, 1990).

Discussion

Potential of Youth to Achieve Indonesia Emas 2045

To achieve the vision of *Indonesia Emas* in 2045, the author sees a lot of potential that young people have. These potentials become a reference that is very relevant to the development of the times. One of them is in the field of economics and technology.

The ability to use technology among youth is becoming a very influential trend in national development. The Internet is one of the sources of income among young people today. The use of social media, *online* stores and even *youtube* media can be a great source of income for young people. And from the utilization of these technologies, economic income becomes a source of state income.

From this report it can be known that the very large range of the whole index of each province illustrates that the democracy of Indonesian society is still very diverse and it is found that the variable of freedom of expression is still in a low range. If this continues, the period will cause division among the community. There needs to be good socialization and monitoring by the government and the community in order to create a healthy politics as the initial capital to go towards the vision of *Indonesia Emas 2045*.

Important Meaning of Bela Negara for Youth

Bela Negara became important for national development and became a form of implementation of law No. 3 of 2002 on State Defense. The purpose of The State Defense could be seen more clearly and deeply through the defense perspective. The anticipation of the founders of the nation is listed in one of the national goal points, namely "Protecting the entire Indonesian nation and all Indonesian blood". This statement becomes the basis of the purpose of defense. It does not stand alone but shares space with the purpose of security or civil order and side by side 3 (three) other goals, namely the goal of welfare (advancing the general welfare), the goal of civility (educating the life of the nation) and the goal of peace (actively participating in a just and lasting world peace). ²

Indonesia's cultural value has also declined with the times. The number of outside cultures that enter unfiltered has a negative impact on the younger generation. To achieve *Indonesia Emas 2045* awareness of Indonesia's identity and love of the homeland is needed so that in the future Indonesia can become a developed country and continue to develop without forgetting its identity and diversity.

Gotong royong culture, mutual respect has begun to fade in the times. From the results of the survey it was found that tolerance is an attitude or field that must be prepared. History also shows us all that Bela Negara is not only done by force of arms. In the mandate explained various threats that are and will be faced by the Indonesian nation, ranging from challenges in managing plurality, waves of free trade and integras pressures n regional economies, to the mastery of access to maritime resources, energy and food, and the challenges of poverty, underdevement and inequality.

In fact, there are basic values contained in the defense of the country. These values are known as basic values of state defense. These values are:

a. Love of the Homeland

By understanding the existence of Indonesia as a whole, it will foster the basic values of Bela Negara as a sense of love as a warrior nation, a sense of belonging as the next generation, and a sense of responsibility as an expression of gratitude to Allah SWT. By understanding the conception of nationality embraced by the Indonesian nation, it is expected that it will give birth to a state-martial attitude that upholds the values of unity and unity based on nationalism and patriotism to strengthen national resilience that is nusantara-minded. Hadith can also be an implementation in surat An Nisa verse 59 about obedience to Allah, The Apostle and *Ulil Amri* (leaders). In this case *Ulil Amri* is the Indonesian government that asks the community, especially the youth, to Bela Negara that became the initial foundation of indonesian state defense. The foundation becomes a good to realize a just society that is blessed by Allah SWT.
